<p>Personal fouls by opponent of scoring team</p> <p>Live-ball fouls enforced as dead-ball fouls</p> <p>Enforce on the try or succeeding kick-off.</p> <p>If last play of the quarter, extend for try only.</p> <p>If last play of second quarter, enforce on kick-off to start the 3<sup>rd</sup> quarter.</p> <p>If last play of 4<sup>th</sup> quarter, must be enforced on the try.</p>	<p>Dead-ball fouls by either team</p> <p>Enforce on the try or succeeding kick-off.</p> <p>If last play of the quarter, extend for try only.</p> <p>If last play of second quarter, enforce on kick-off to start the 3<sup>rd</sup> quarter.</p> <p>If last play of 4<sup>th</sup> quarter, must be enforced on the try.</p>	<p>Dead-ball fouls by either team.</p> <p>Enforce at succeeding spot.</p>	<p><b>Offsetting Fouls</b> Replay the try from previous spot.</p> <p><b>Foul by Team B</b> Team A option of declining the score and repeating the try after enforcement, or declining the penalty (ies) and accepting the score.</p> <p>Team A may accept the score with <b>penalties for personal fouls enforced on the succeeding kickoff or from the succeeding spot in extra periods.</b></p> <p><b>Foul by Team A</b> After a foul by Team A on a successful try, the ball shall be put in play at the spot where the penalty leaves it.</p> <p>If Team A commits a foul for which the penalty includes loss of down, the try is over, and the score is canceled, and no yardage penalty is assessed on the succeeding kickoff.</p> <p>If before a change of team possession Team A commits a foul that is not offset, and during the down there is neither another change of team possession nor a score, the penalty is declined by rule.</p> <p><b>After change of team possession</b> Distance penalties against either team are declined by rule (Exception: <b>Penalties for flagrant personal fouls, dead-ball fouls and live ball fouls treated as dead-ball fouls are enforced on the succeeding kickoff or at the succeeding spot in extra periods.</b>)</p> <p>A score by a team committing a foul during the down is canceled.</p> <p>If both teams foul during the down and Team B had not fouled before the change of possession, the fouls offset, the down is not replayed, and the try is over.</p>	<p>Penalties for fouls occurring after a try are <b>enforced on the succeeding kickoff or from the succeeding spot in extra periods.</b></p> <p>However, if the try is replayed, these penalties are enforced before the replay</p>
